POLICY STATEMENT AND AGREEMENT FOR THE Y4LIFE IN WASHINGTON, D.C. 2024 TRIP REGARDING TRIP CONDUCT

Participation in the Y4Life in Washington, D.C. 2024 trip is a voluntary act. The following rules and restrictions are instituted for the safety and welfare of the students/youth. As such, participants must agree to the following rules of conduct. Parents and/or guardians likewise must agree to the terms for their child to participate.

- I. No student on the Y4Life in Washington, D.C. 2024 trip may drink or be in possession of any open alcoholic beverage at any time during the trip.
- II. No student on the Y4Life in Washington, D.C. 2024 trip may use or be in possession of any tobacco or tobacco product at any time during the trip.
- III. No student on the Y4Life in Washington, D.C. 2024 trip is to be in possession of any weapon, firearm, ammunition, or explosive device at any time during the trip.
- IV. No student on the Y4Life in Washington, D.C. 2024 trip shall get a tattoo or body piercing while on tour.
- V. No student on the Y4Life in Washington, D.C. 2024 trip shall, for his/her own safety, operate any motorized vehicle or be a passenger on any motorcycle or anyone's personal car.
- VI. No student on the Y4Life in Washington, D.C. 2024 trip may use or be in possession of any non-prescription drug at any time, except for those that have been administered by a leader with permission from a parent.
- VII. No student on the Y4Life in Washington, D.C. 2024 trip shall leave the group unless the supervisor is aware, has given permission, and knows the time of return, whereabouts, and the returning location of the student.
- VIII. No student on the Y4Life in Washington, D.C. 2024 trip shall be out at night for any reason; students are to be in their rooms by 11:00 each night for check-in unless otherwise notified.
- IX. No student on the Y4Life in Washington, D.C. 2024 trip should be alone for any reason, especially after dusk; students shall always be in groups of three or more.
- X. No student on the Y4Life in Washington, D.C. 2024 trip shall be in the room of a member of the opposite gender nor are other individuals not on the trip welcome in the student's room.
- XI. All students will honor the rules of punctuality, behavior in hotels and transportation modes, respect for adult leaders, and all else asked of them, proving themselves to be excellent ambassadors for their school/church and for Christ.

Disciplinary measures are as follows:

- I. Following the first offense for rules I through V, the student must telephone his/her parents/guardian and explain his/her actions. This is to be done as soon as possible and at the student's expense.
- II. For any subsequent offense of rules I through V, the student will be sent home alone on the first available transportation, at the parent's/guardian's expense.
- An infraction of rules VI through XII will result in a warning. If the action occurs III. again the student will be partnered with a teacher/pastor/chaperone for a specified amount of time, no less than a day.
- Repeated infractions of rules VI through XII may result in the student returning home IV. at his/her own cost.
- V. In accordance with the policies established by _____ School, any infraction of the rules regarding alcohol, tobacco, or drugs may be punishable upon return.
