

# What kinds of abortion are there?



## Medical abortion

is the use of **2** medications to end a pregnancy.


Mifepristone, taken first, causes the mother to stop progesterone production. This causes the uterine lining to thin, and the baby can no longer remain implanted or receive nutrients.

Misoprostol, taken later at home, causes contractions to expel the baby (also known as an embryo at this stage) from the uterus through the vagina.

Medical abortion is currently done through **10 weeks** gestation.

It accounted for **53 %** of all abortions in the US in 2020...

...up from **39%** in 2017 and from **5%** in 2001.



# Surgical abortion

ends a pregnancy by killing and removing the baby, or fetus, with surgical tools.

There are several types of surgical abortion; the method chosen depends on how far along the mother is.

In the **first trimester**, the abortion occurs by suctioning the baby out after dilating the cervix.

**From week 13 on**, forceps are necessary for dismemberment because the baby is too developed to be removed through suction.

Often, other chemicals are used to assist with the abortion as well.

Partial-birth abortion, which involves delivering the baby alive and then snipping the spinal cord, is not currently legal in the U.S.

In 2020, **6.7%** of abortions in the US were performed after 13 weeks.

# 62,321

babies killed in the womb by dismemberment and/or chemical injections in our country in one year.

# Who has abortions?

By the age of 45, nearly

**1 in 4**

women have had an abortion.




61% of those choosing abortion have already given birth to at least one child.

Women ages 20-29 make up 57% of those who get abortions.




# Abortion distribution by...



Abortion is disproportionately common among women who are:




in their twenties


